This show will be conduct auditions in different states of India. 20 states have been targeted for the audition while participation of 500 models from each state is been expected overall summing up to 10000 participants.

The models will be scoured according state wise.

There will be three rounds in the state auditions where from 500 only 50 models will be selected, then the 50 models further will be filtered into top 3. Therefor, top 3 models from each state will be part of finale team.

1-Who is eligible to participate:-

They would be young single women's (from 18-28 years.) The contestant will be assigned to the age according to the contestant's age one 28th Feb 2019. 2-Official Language:- Hindi/English are the official language of the pageant; it is not a requirement for participants to speak English. 3-Contractual obligations:- Entrant may have a modeling, commercial tie-up, personal management and or agency contract, which contract however does not include authorize or permit to use of the name of the Miss Super Model or Style Guru or any Title designation or reference with respect to the pageant in any manner.

4-Determination:-

All issues as to eligibility shall be determined solely by the managements. Participants agree to abide by eligibility determination both as to her and others.

5-JUDGING INFORMATION

- (A) Our vision is not to judge participate while our view to support, promote and make them inspire with this show but we have certain criteria for the show.
- (B) Minimum of 4 judges will evaluate delegates in the different areas of competition:
- (C) All areas of competition are equally weighted
- (D) Management has sole discretion and complete authority to select judges.
- (E) Reasonable efforts are made to secure a culturally and professionally diverse panel of judges. Judges' names are not released to delegates prior to arrival at the pageant.
- (F) May not approach the judges or engage in conversation with judges prior to or during the competition.

Who are observed approaching a judge or engage in conversation with a judge beyond a brief greeting risk immediate disqualification at the discretion of the management are provided with training and instruction regarding scoring procedures prior to the competition. The decision of the judges is final and not contestable for any reason.

6-Requirements

- (A) Photography: Entrant must submit a headshot photo
- (B) Cloth: Delegates provide their own competition attire if required.

- 11-Areas of competition for the 2019 Miss Super Model International includes:
- (a) Opening production round- This is specific first round going to be held at every major city of state as per participate. Delegates will be provide sponsors t shirt for opening number as specified by the management information about 2019 opening production number. The opening production round is not judged and it's for short list the candidate as per criteria.

Introduction round - It's going to be held at 4 major cities of India and based on introduction of participate and them qualification. Introduction round is first stage of counting number point as per performance. This round is simple one and will be judged with the same outfit will be sponsored by company.

Personality and vision round – Must introduce herself who reflect her personality, confidence, and smartness. Judges may ask some question about her vision and passion which inspire her and make inspiration for others to be part of fashion industry.

- (b) Costumes round-Judging criteria: modelling, personality, beauty, grooming and fashion sense. In all phase of competition the judges are instructed to evaluate contestant by asking few question about the outfits.
- (1) Traditional- Holder must be able to project her own personal sense of style. This competition will be very much like a runway fashion show. Fashion cloth can be anything the delegate feels represents a currently popular or stylish ensemble. Judges will be looking for high energy, spirit, and the delegate's sense of confidence ,walk, posture, carriage and grace, personality, stage presence, beauty and sense of attraction and appropriateness.





- (3)Free style/ casual- Holder are free to choose costumes according to them choice; judges will not be evaluating the cost or designer label of the costumes. Remember this high-value programmed so management have authority to ban inappropriate swim wear or costumes.
- (4) Specialized professional costumes-This phase is 10% of total costumes score. Holder must introduce herself in them professional working outfits, the judges are evaluating first impression with beauty of face and statement of physical fitness and health, sense of confidence and comfort in your ability to compete in this phase of competition, display of energy, charisma, expression as well.
- (c) Talent round- This specific talent round what participates hobby, passion and extra curriculum activity she can do apart from career. The time limit for competitor is 90 second and contestant must begin and finish on stage, no live animal and dangerous props are allowed (fire, baton, or swords)all probes must be functional and an integral part of talent. When choosing any function of work to do in this round participate must keep in mind the value and image of miss aviation India.
- (d) Special round- This is undefined round, where judges can surprises with them question and answer, where judges are looking for quality and attributes of Miss Super Model positive role model, knowledge, and understanding of platform's, ability responsibility, confident and commanding, presence, personality, appearance, validated opinions and responses, ability to express feeling, defend beliefs, energy and communication skill.

(e) On stage final round-Finalist holder must be able to express herself with confidence. Finalist will response to few question on stage to earn up to 10% of bonus points which will be added to each finalist composite score. The question may take from information listed on the delegates face sheet. Judging are evaluating your extemporaneous responses to the onstage question, poise, confidence and comfort level in speaking before a large audience.
